<u>Robert Chevalier</u> — Would like to know if the Township has a line of communication to the local State Police? The township has a very good relationship with the State Police, however according to articles written in the past few years the PA Sate Police are suffering from the lack of employable people. This has created challenges when you're asking for their help with traffic concerns with Beltzville tourists. The police do respond to residents concerns & known emergencies.

<u>Frank Pipolo</u> – Just built home in Beltzville Lake Estates and Mr. Faust was out there inspecting and one of the things that surfaced was the driveway needed to be paved at least 50 feet from road. The driveway is graded and stone was put down. He is looking for some help because he was told the moving company would destroy the driveway if it was freshly paved. The paving contractor has not given Mr. Pipolo a starting date. Asking if he can give the township a check to hold in escrow and be reimbursed when paving passes. Reply, the driveway needs to be paved. During winter months when the asphalt plants aren't open, we have made exceptions. This is not the current situation; you will be required to pave at least the first 50 foot of driveway.
