## PLANS AND SUBDIVISIONS

<u>Billingsby</u> – Conditional approval was granted by planning commission on April 11, 2022. Asking for driveway waiver to not pave the 50 ft on both sides of driveway. A motion was made to approve plan, waiver for driveway not being pave is not approved. Motion, Guy – Scott 2<sup>nd</sup> AIF – Motion Carried. Motion for conditional approval that driveway will be paved from street to right-a-way at both ends of driveway in a 12 month period prior to final plans being signed.
