There was an incident this past weekend with an electric bicycle. We will send what we have in place as an ordinance and possibly write resolution to fix this. Alison noted there was a fender bender and they called the police and they said there is nothing they can do about it. It was second hand information so do not know much about it. Here as a citizen and live on Pheasant Hill Rd and have an acentric neighbor and believes that the front of the road is her property. She puts river rocks around her property and signs that say please do not walk on the rocks. I have a problem with this because I have kids walking to the bus stop with no room to move over. Feels this has become a safety issue. Alison wants to know where the right away is? Understand that property owners do own to the end of the road but they cannot obstruct the right away. Now if she is we can send a violation letter. Otherwise, we cannot get involved in a civil matter it would have to be a police matter. Should fill out signed formal complaint. Jessica to find Ordinance and send to Tom in regards to bikes on fields.

<u>Rick Anderson – The Lutheran Church called and stated they have a SEO problem relating to Jerusalem UCC.</u> Wanted to know, is the Jerusalem UCC responsible for this bill? The bill was is the responsibility of the Lutheran Church. Township will rebill correctly.

<u>Shereshevsky, Leonid & Marina</u> – Surveyor asked to review letter from Planning Commission. Plan presented to board. Supervisors reviewed plan. Guy asked for timing which is Aug 6, 2023. Discussion with Surveyor & Engineer about conditions to Supervisors not yet met. Guy made a motion to give conditional approval based on following conditions to be met:

- 1. The Plan shall include the name and address of the proposed Landowner after the lots are consolidated. [Sec. 401.A.4.4.a]
- 2. The 'Owners Statements' on the plan shall be <u>titled 'Certificate of Ownership and Acknowledgement</u> of Plan'. The Certification shall also be signed by Both the Owners & Corporation and notarized prior to recording the Plan. [Sec. 401.A.5.a]
- 3. A proposed deed description for the consolidated lot shall be submitted. [Sec. 401.A.5.a]
- 4. Dimensions from the property line to each corner of the existing building & deck located within the building setback shall be provided on the Plan.
- 5. All outstanding review fees must be paid in full before plans can be released.
