

ORDINANCE NO. 2020 - 1
(As Reenacted on July 9, 2020)

AN ORDINANCE OF THE TOWNSHIP OF TOWAMENSING, CARBON COUNTY, PENNSYLVANIA PROHIBITING PARKING ALONG CERTAIN ROADS WITHIN THE TOWNSHIP; PROVIDING FOR REMOVAL AND IMPOUNDING OF VEHICLES PARKED IN VIOLATION OF THIS ORDINANCE; AND PROVIDING PENALTIES FOR VIOLATION OF THIS ORDINANCE.

The Board of Supervisors of Towamensing Township ("Board of Supervisors") hereby ordains:

Section 1. Definitions and Interpretation.

- a. Words and phrases, when used in this ordinance, except for sections or parts to which different or additional definitions apply, shall have the meanings ascribed to them in The Vehicle Code, 75 Pa. C.S.A. § 101, et seq., as amended ("Vehicle Code"), except that, in this ordinance, the word "street" may be used interchangeably with the word "highway", and shall have the same meaning as the word "highway" as defined in the Vehicle Code.
- b. "Township" shall mean Towamensing Township, Carbon County, Pennsylvania.
- c. In this ordinance, the singular shall include the plural, the plural shall include the singular, and the masculine shall include the feminine.



Section 2. Parking Prohibited at All Times in Certain Locations. Parking shall be prohibited at all times in the following locations:

Street	Side	Between
Deer Lane (T-439)	Both	Pohopoco Drive (T-435) and Lakeside Drive (T-436)
Jefferson Street (T-417)	Both	Franklin/Towamensing Township Boundary Line and T-464
Lakeside Drive (T-436)	Both	Pohopoco Drive (T-435) and Station Street (T-437)
Lakeview Drive (T-551)	Both	Pohopoco Drive (T-435) and Station Street (T-437)
Pine Run Road (T-464)	Both	Pohopoco Drive (T-435) and Jefferson Street (T-417)
Pohopoco Drive (T-435)	Both	Franklin/Towamensing Township Boundary Line and T-490
Station Street (T-437)	Both	Pohopoco Drive (T-435) and Lovitt Road (T-527)



- Section 3. Penalties.** Any person who violates any provision of this ordinance shall, upon conviction, be sentenced to pay a fine in the amount of one hundred dollars (\$100.00), or the maximum amount permitted by law, whichever is lesser. Each day that a violation of this ordinance continues shall constitute a separate offense.
- Section 4. Authority to remove and impound.** The Township, its parking enforcement personnel, and any police officer with authority to act in the Township, including state police officers, shall have the authority to remove and impound or to order the removal and impounding of any vehicle parked in violation of this ordinance.
- Section 5. Enforcement.** This ordinance may be enforced by parking enforcement personnel appointed by the Board of Supervisors, or by any police officer, including state police officers, with authority to act in the Township.
- Section 6. Restrictions on removal of vehicles.** No vehicle shall be removed under the authority of this ordinance if, at time of the intended removal, the owner or the person for the time being in charge of the vehicle is present and expresses a willingness and intention to remove the vehicle immediately.
- Section 7. Repealer.** All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.
- Section 8. Severability.** If any sentence, clause, section, or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this ordinance. It is hereby declared as the intent of the Board of Supervisors that this ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
- Section 9. Effective Date.** This ordinance shall become effective on July 15, 2020.
