## RESOLUTION NO. 2021 – 7

(Duly Adopted January 21, 2021)

A RESOLUTION OF TOWAMENSING TOWNSHIP, CARBON COUNTY, PENNSYLVANIA AUTHORIZING THE SUPERVISORS OF TOWAMENSING TOWNSHIP AND THE CODE ENFORCEMENT OFFICER TO ENFORCE TOWAMENSING TOWNSHIP ORDINANCE NO. 2019-1.

WHEREAS, Towamensing Township is a township of the second class located in Carbon County, Pennsylvania; and

WHEREAS, pursuant to section 1601(a) of The Second Class Township Code, 53 P.S.§ 66601(a), the board of supervisors may adopt ordinances in which general or specific powers of the township may be exercised; and

WHEREAS, pursuant to section 1601(c.1) of The Second Class Township Code, 53 P.S. § 66601(c.1), an ordinance enacted by the board of supervisors shall unless otherwise specified in another statute, designate the method of its enforcement; and

WHEREAS, on or about February 7, 2019, the Board of Supervisors of Towamensing Township enacted Ordinance No. 2019-1 entitled, "AN ORDINANCE OF THE TOWNSHIP OF TOWAMENSING, CARBON COUNTY, PENNSYLVANIA PROHIBITING LITTERING AND DUMPING ON TOWNSHIP OWNED PROPERTY; PROVIDING FOR THE DEPOSIT OF DESIGNATED RECYCLABLE MATERIALS AT RECYCLING FACILITIES; DEFINING MEANING OF TERMS AS USED IN THIS ORDINANCE; AND PRESCRIBING PENALTIES FOR VIOLATIONS."; and

WHEREAS, section 8 of Ordinance No. 2019-1 provides, "This ordinance shall be enforced by the Board of Supervisors of the Township, or a person designated by resolution duly adopted by the Board of Supervisors of Towamensing Township."; and

WHEREAS, by this Resolution, the Board of Supervisors of Towamensing Township desire to recognize the authority of the Supervisors of Towamensing Township and the Code Enforcement Officer to enforce Ordinance No. 2019-1.

NOW, THEREFORE, BE IT RESOLVED, as follows:

**RESOLVED,** the Board of Supervisors of Towamensing Township hereby recognizes the authority of the Supervisors of Towamensing Township and the Towamensing Township Code Enforcement Officer to enforce Ordinance No. 2019-1.

**RESOLVED FURTHER,** this authority is given to not only the current Supervisors of Towamensing Townhip (Guy Seifert, Scott Mosier and John Kleintop) and the current Towamensing Township Code Enforcement Officer (Carl Faust), but to those persons who may hold those respective positions in the future.
