## TOWAMENSING TOWNSHIP CARBON, PENNSYLVANIA

## RESOLUTION NO. <u>2033</u> - 1

A RESOLUTION OF THE BOARD OF SUPERVISORS OF TOWAMENSING TOWNSHIP, CARBON COUNTY, PENNSYLVANIA, REVISING THE SERVICE CHARGE FEES FOR TAX CERTIFICATIONS AND FOR DUPLICATE TAX BILLS PREPARED BY THE TAX COLLECTOR

WHEREAS, Towamensing Township ("Towamensing") is a township of the second class located in Carbon County, Pennsylvania; and,

WHEREAS, on April 5, 2012, Towamensing enacted Ordinance No. 2012-1 entitled, "An Ordinance of Towamensing Township, Carbon County, Establishing Service Charge Fees for Tax Certifications and for Duplicate Tax Bills Prepared by the Tax Collector."; and,

WHEREAS, section 2 of said Ordinance No. 2012-1 provides, "Service fee for tax certifications: The tax collector is authorized to charge a service fee of fifteen (\$15.00) dollars, upon each person requesting a tax certification. Each tax certification shall address the status of township, county and school real estate taxes."; and,

WHEREAS, section 3 of said Ordinance No. 2012-1 provides, "Service fee for tax duplicates: The tax collector is authorized to charge a service fee of six (\$6.00) dollars, upon each person requesting a duplicate tax bill. That is, if a person requests a duplicate tax bill for township, county or school real estate taxes, the authorized service fee shall be six (\$6.00) dollars for each duplicate tax bill."; and,

WHEREAS, section 4 of said Ordinance 2012-1 provides, "The Township may from time to time, by resolution, change the amount of either or both of the above service fees."; and,

WHEREAS, by this Resolution the Board of Supervisors of Towamensing Township desires to change the amount of both the service fee for tax certifications and the service fee for tax duplicates.

## NOW, THEREFORE, BE IT HEREBY RESOLVED, as follows:

- 1. The service fee for tax certifications is increased from fifteen (\$15.00) dollars to twenty (\$20.00) dollars. Therefore the tax collector is authorized to charge a service fee of twenty (\$20.00) dollars, upon each person requesting a tax certification.
- 2. The service fee for tax duplicates is increased from six (\$6.00) dollars to ten (\$10.00) dollars. Therefore, the tax collector is authorized to charge a service fee of ten (\$10.00) dollars, upon each person requesting a duplicate tax bill.
