**A RESOLUTION OF TOWAMENSING TOWNSHIP,
CARBON COUNTY, PENNSYLVANIA AUTHORIZING THE
SUPERVISORS OF TOWAMENSING TOWNSHIP TO
ENFORCE TOWAMENSING TOWNSHIP ORDINANCE NO.
2016-2.**

WHEREAS, Towamensing Township is a township of the second class located in Carbon County, Pennsylvania; and,

WHEREAS, pursuant to section 1601(a) of The Second Class Township Code, 53 P.S. § 66601(a), the board of supervisors may adopt ordinances in which general or specific powers of the township may be exercised; and,

WHEREAS, pursuant to section 1601(c.1) of The Second Class Township Code, 53 P.S. § 66601(c.1), an ordinance enacted by the board of supervisors shall unless otherwise specified in another statute, designate the method of its enforcement; and,

WHEREAS, on or about May 5, 2016, the Board of Supervisors of Towamensing Township enacted Ordinance No. 2016-2 entitled "AN ORDINANCE OF TOWAMENSING TOWNSHIP DEFINING AND REGULATING DRIVEWAY CONSTRUCTION; SETTING FORTH REQUIREMENTS FOR PERMIT APPLICATIONS, FORMS AND FEES AND THE APPROVAL AND ISSUANCE OR DISAPPROVAL THEREOF; PROVIDING FOR CORRECTION OF IMPROPER WORK AND PRESCRIBING PENALTIES FOR VIOLATIONS."

WHEREAS, by this Resolution, the Board of Supervisors of Towamensing Township desire to recognize the authority of the Supervisors of Towamensing Township to enforce Ordinance No. 2016-2.

NOW, THEREFORE, BE RESOLVED as follows:


RESOLVED, the Board of Supervisors of Towamensing Township hereby recognizes the authority of the Supervisors of Towamensing to enforce Ordinance No. 2016-2.
