**A RESOLUTION OF TOWAMENSING TOWNSHIP,
CARBON COUNTY, PENNSYLVANIA, AUTHORIZING THE
ENTRY INTO AN INTERMUNICIPAL COOPERATION
AGREEMENT WITH PARRYVILLE BOROUGH
REGARDING WASTE COLLECTION SERVICES**

WHEREAS, Towamensing Township is a township of the second class located in Carbon County, Pennsylvania; and,

WHEREAS, Parryville Borough is a borough located in Carbon County, Pennsylvania; and,

WHEREAS, the Pennsylvania Intergovernmental Cooperation Act, 53 Pa. C.S.A. § 2301, *et seq.*, authorizes municipalities to enter into agreements to perform governmental functions, powers, or responsibilities; and,

WHEREAS, Parryville Borough desires to secure reliable refuse collection services for its residents and commercial entities; and,

WHEREAS, Towamensing Township possesses the equipment, personnel, and licensure to provide such waste hauling services and is willing to provide them to Parryville Borough under the terms set forth herein.

NOW, THEREFORE, BE IT HEREBY RESOLVED, as follows:

1. Towamensing Township shall enter into the Intermunicipal Agreement for Waste Collection Services (“Intermunicipal Agreement”) with Parryville Borough, which Intermunicipal Agreement is attached hereto and made a part hereof as Exhibit “A”.

2. The terms and conditions of the Intermunicipal Agreement are stated in the Intermunicipal Agreement attached hereto as Exhibit "A".

3. The duration of the Intermunicipal Agreement shall be from February 5, 2026 until December 31, 2026.

4. The purpose of the Intermunicipal Agreement is to enable Towamensing Township to provide refuse hauling services to Parryville Borough; and, the objectives of the Intermunicipal Agreement are to, *inter alia*, provide Parryville Borough with reliable refuse collection services by Towamensing Township for Parryville Borough's residents and commercial entities.

5. The manner and extent of financing the Intermunicipal Agreement are stated in the Intermunicipal Agreement attached hereto and made a part hereof as Exhibit "A", and specifically in sections II (1), III (1), and III (2).

6. The organizational structure necessary to implement the Intermunicipal Agreement are stated in the Intermunicipal Agreement attached hereto and made a part hereof as Exhibit "A", and specifically, Towamensing Township possesses the equipment, personnel, and licensure to provide such refuse hauling services to Parryville Borough.

7. The Intermunicipal Agreement does not provide for the acquisition of real or personal property by either Towamensing Township or Parryville Borough.

8. The Intermunicipal Agreement does not contemplate the creation of a new entity and will not have any affect on policies of group insurance and employee benefits, for either the employees of Towamensing Township or Parryville Borough.
