#### **APPROVAL OF MINUTES:**

Bob made a motion to approve the February 10, 2025, Meeting Minutes - Bruce 2<sup>nd</sup> - AIF - Motion Carried.

### **PUBLIC PARTICIPATION:**

Wayne Davis was in attendance and described his project being contemplated for the Beltzville Beverage property at 70 Church Drive. He explained that the proposal would be to create a restaurant having a capacity of 100 people. He's already submitted an Application for the construction of an Onlot Sewage Disposal System and has been working with Ian Farrell on the required sewage planning for the property. Specifically, Wayne asked if a Land Development Plan would be necessary to be submitted. Greg explained that he recently spoke with Mark Singleton regarding this and had concluded that due to necessary site improvements for parking and traffic circulation, that by the definition in the Subdivision and Land Development Ordinance a Land Development Plan would be required. However, since Wayne stated that preliminary site plans have already been prepared by his Consultant, Greg recommended that Wayne present the project as a Sketch Plan for informal discussions at the next meeting.

### **OLD BUSINESS:**

<u>Lakeside Self Storage Land Development (Sunrise Lehighton Group)</u> – No revised Plan has been submitted. No one representing the Plan was present. No action was taken.
