**Bryon Hahn Minor Sub-division**: Brad Rock mentioned they have some good news that Larry Hahn purchased the vacant lot that has a valid perc test but the lot is still unsuitable for building. Larry is still going ahead with building on lot two originally proposed. Looking to remove the Overlook Drive and change back to original land go ahead with original building and driveway. We do have the handwritten driveway maintenance agreement from Sal Lizzio. This will keep them in zoning regulations. There was discussion about new shape of lot. Planning commission went through review comments asking for waiver on all existing manmade features on 100' of project boundary to be shown on plan and replaced with aerial view and show wells and septic systems and block off houses. Brad asked for conditional approval to submit plans to supervisors after all review comments are met and fee schedules are paid. Rick asked if there was discussion about the Overlook Drive you are eliminating. We do not have authority to eliminate roads Rick made motion to give conditional approval of Bryon Hahn minor sub-division plan Bruce 2<sup>nd</sup> – AIF, Motion Carried
